## FINAL DECLARATION

# THIRD NATIONAL ENCOUNTER OF DAM-AFFECTED PEOPLE AND IN DEFENSE OF RIVERS (MAPDER)

## MEXICO CITY DECLARATION

In Mexico City, on the 18th of March, 2006, we have held the **III Encounter of the Mexican Movement of Dam-Affected People and in Defense of Rivers (MAPDER)**. The 385 delegates from communities affected by dams and by hydroelectricity projects in the country, as well as from communities affected by river pollution, come from 11 states: Jalisco, Guerrero, Michoacán, Chiapas, Coahuila, Morelos, Nayarit, Distrito Federal, State of México, Hidalgo and Oaxaca, together with guest organizations from Bolivia, Columbia, Spain, the United States and Canada.

In the context of the 4th World Water Forum and of the **International Forum in the Defense of Water**, the organizations participating in the Third MAPDER Encounter ratify our position against the neoliberal model. The only thing this model has left us, after 20 years of implementation, is poverty, lies and marginalization. The government strategy seeks to privilege maximum profits employing a development scheme which facilitates the appropriation of strategic resources by a powerful few and by multinational corporations thus affecting indigenous peoples.

We offer our congratulations for the fact that in Mexico the Latin American Water Tribunal, an ethical and independent tribunal, is holding session. We believe that it represents an important effort seeking to combat the absence of environmental justice which prevails in Mexico and Latin America. The Latin American Water Tribunal is an alternative environmental justice initiative which can contribute to the resolution of water-related problems, and to the management of rivers, lakes and lagoons.

We celebrate the fact that at this same time a series of national and international alternative events in the defense of water, rivers, land and biodiversity are being held, organized by indigenous peoples, and social and civil organizations; it is clear that we are not alone. It is also evident that these movements are growing and becoming stronger, and creating and strengthening bonds between organizations in cities and rural areas in our country, in Latin America and internationally.

In the year that has elapsed between the second and third National MAPDER Encounter, we have successfully resisted the constant aggressions of the Mexican government against our communities, affected by diverse hydraulic megaprojects, especially against our sisters and brothers who oppose the La Parota Dam in the state of Guerrero.

We celebrate the definitive cancellation of the **San Nicolás Dam in the state of Jalisco** as a result of the struggle of the affected communities and the support of MAPDER. Likewise, we celebrate the cancellation of the **Itzantún Dam** project and the definitive suspension of the **Uixtán I and II**, **Usumacinta and Saconeja dams in the state of Chiapas**.

We also celebrate the certain definitive cancellation of the La Parota Dam in the state of Guerrero.

We denounce the company Electricidad del Istmo as the party responsible for constructing the hydroelectric plant which will affect 10,000 people from the community Nueva Santa María Jalapa del Márquez, in the state of Oaxaca, in conspiracy with the state government.

#### IN THE III MAPDER ENCOUNTER WE DEMAND:

1. The definitive cancellation of the following dams: La Parota in Guerrero, Arcediano and El Zapotillo in Jalisco and La Yesca in Nayarit and Jalisco.

- 2. The suspension of the construction work and the flooding of the communities affected by the El Cajón Dam in the state of Nayarit.
- 3. That the water level of the reservoir not be raised and more turbines not be installed at the hydroelectric plant of the Benito Juárez Dam, as this would result in the further displacement of 10,000 people from the community Nueva Santa María Jalapa del Márquez, in the state of Oaxaca.
- 4. The definitive destruction of the La Venta Dam, installed in the Ejido la Palma, municipality of Juan R. Escudero, Tierra Colorada, in the state of Guerrero, as it has completed its useful life.
- 5. The dismantling of all of the country's dams that have completed their useful life, thus guaranteeing the freeing of the affected rivers and the reparation of the environmental damage and the damage done to the affected communities.
- 6. That the repression and threats to the leaders of the Resistance Movement cease, especially against our companion Marco Antonio Suástegui Muñoz of the La Parota Dam, María Guadalupe Lara of the Arcediano Dam, and Francisco Villa of the El Cajón Dam. Cessation as well of threats to and repression of the members of the diverse organization that support the Movement.
- 7. The immediate liberation of our companion Margarito Castillo Manrique from the ejido Dos Arroyos, opponent of the La Parota Dam, prisoner in the prison facility in Acapulco, Guerrero since December 16<sup>th</sup>, 2005.
- 8. We condemn the murder of our companion Tomás Cruz Zamora of Huamuchitos, Guerrero, killed on September 18th, 2005. As well as the murder of our companion Eduardo Maya Manrique of the Ejido Dos Arroyos, Guerrero, killed on January 29th, 2006. Both were opponents to the construction of the La Parota Dam.

# IN THIS ITS THIRD ENCOUNTER, MAPDER:

- 1. Continues to strengthen and consolidate itself as a Movement, creating connections with diverse national and international networks with which it shares the struggle in defense of water and biodiversity, including the Guatemalan Front Against Dams and the Latin American Network against Dams and for Rivers, their Communities and Water (REDLAR).
- 2. Offers its thanks for the support of our companion Alfredo Zúñiga, expert hydrologist from Jalisco who passed away after the Second Encounter.

With this declaration MAPDER continues with the struggle of resistance in defense of our rivers, water, land and communities and against the construction of dams in our country.
